

**INVITATION TO TENDER FOR SUMMER SKID STEER/TRACKED LOADER

**OVERVIEW:**

The Resort Village of Turtle View requires the services of a contractor for summer Skid Steer / Tracked Loader and Dump Truck work as described below.

The Contractor will provide his own equipment, fuel, manpower, and 2 million liability insurance specific to the machinery used and work description.

**INSTRUCTIONS TO TENDERERS:**

This invitation covers work within the boundaries of the Resort Village of Turtle View, which includes the subdivisions of Sandy Beach, Turtle Lake Lodge, Indian Point and Golden Sands, the Transfer Station and Lagoon.

The following is a description of work required pertaining to this invitation to tender:

Provide skid steer/tracked loader and dump truck equipment and services within the Resort Village as follows:

- Co-ordinate loading or unloading of calcium chloride on demand.
- Provide Skid Steer/track loader and dump truck for miscellaneous work.

Preference will be given for the following:

Equipment supplied:

Dump truck.  
Skid steer/track loader.  
Buckets, grapple, auger, pallet fork and track drive train.

Skid steer / track loader specs:

Minimum of 2100 lb operating capacity  
Minimum of 3000 lb (50% of tip) lift capacity  
Minimum of 6000 lb tipping Load.

Please provide an hourly and half hourly rate for this work.
