RESORT VILLAGE OF TURTLE VIEW MUNICIPAL PROPERTY AND LAND POLICY

Subject:	Municipal Property and Land Policy	
Type:	Administrative	
Authority:	Municipal Resolution #190/23	

1. Purpose

The purpose of this policy is to regulate the actions to change or alter the land and vegetation on all municipal property and environmentally sensitive municipally owned land.

2. Scope

This policy applies to all ratepayers and contractors working on any Municipal property.

3. Policy

This policy states the following:

- a) All work (tree cutting, moving of rocks, removing/altering vegetation, etc) on municipal property must have Council approval.
- b) All work must be done by a person or contractor who is certified for the work to be completed and paid for by the ratepayer requesting the work.
- c) The minimum certification requirement for tree removal on municipal property is the Chainsaw Safety Training Certification which will be provided to the Municipal office before council approval will be given.
- d) A liability waiver agreement will be required to be in place for tree removal on municipal property by individuals.
